What is OBU Bsc (Hons) Degree in Applied Accounting?

ACCA and Oxford Brookes University have worked together to develop a BSc (Hons) Degree in Applied Accounting, which is available exclusively to ACCA students who wish to obtain a degree while studying towards the ACCA Qualification.

There are lots of benefits to completing the degree, the main one being a degree and a professional accounting qualification are a powerful combination of qualifications to have, putting you in demand with employers and increasing your career prospects.

To be awarded the BSc (Hons) in Applied Accounting you must:

1. be registered with Oxford Brookes University ie have opted in to the BSc degree scheme and hold a suitable English language qualification before passing any of the three ACCA Fundamentals papers, F7, F8 and F9.
2. successfully complete all nine Fundamentals level papers
3. complete the ACCA Professional Ethics module
4. complete and pass the Oxford Brookes University Research and Analysis Project.
