## TERMS AND CONDITIONS

- When two or more siblings are enrolled in full-fee paying courses in the same or past semesters, a discount may be applied for the course fees.
- The student must be one of two or more children having both parents in common. This discount is not available to family members outside the sibling relationship such as step brother/sister, cousins, spouses and so on.
- The student must provide documentary evidence of relationship (e.g. birth certificate). All photocopies of documents must be certified and, if necessary, translated into English. International students need to provide both certified copies of passport (photo and visa page) and birth certificates.
- Evidence of successful completion of a course of study at Methodist College Kuala Lumpur for all siblings need to be produced (eg. leaving certificate, diploma, certificate...). If one sibling did not complete a full course at the College, that sibling cannot be counted as a qualified sibling for the purpose of this application.
- This discount cannot be combined with other offers such as scholarships, vouchers, etc.
- The discount will not be given if the applicant is a scholarship holder of the College or other forms of scholarship/financial aid from other organizations or parties.
- The discount can only be used as a reduction in course tuition fees. It is not transferable or redeemable for cash or other monetary assets.
- Application for the Sibling Discount must be received with the Application for Admission and appropriate registration fees for newly enrolled students.
- The College reserves the right to revoke or change the quantum of the discount at its sole discretion.
